**ONNA MONIZ-JOHN PARK AND CENTRAL AVENUE PLAYGROUND ATHLETIC COURT IMPROVEMENTS PROJECT**

The City of East Providence hereafter called the “Owner” will receive sealed bids for the RFP Bid Number EP14/15 - 37 is seeking sealed bids for the Onna Moniz-John Park and Central Avenue Playground, Map 205, Block 18, Parcel 29 Central Avenue, East Providence, RI as outlined in the specifications.

Sealed bids will be received in the office of the City Manager, Room 102, City Hall, 145 Taunton Avenue, East Providence, RI 02914 until 2:00 PM on Tuesday, October 13, 2015. The bids will be publicly opened at that time. Bids stamped with a time of 2:01 PM or later will be rejected.

Bidders must provide THREE copies of their proposals submitted in sealed envelopes marked with RFP BID EP14/15 - 37 number, and “Onna Moniz-John Park and Central Avenue Playground Athletic Court Improvements Project” on the outside.

Fundamental Components of the project:

- Furnish all labor, materials and incidental items necessary to complete this project.
- Furnish, install, maintain and remove all necessary materials and equipment.

The specific scope of services will be detailed in the bid request, and the final award will be based on the lowest qualified evaluated bid price. A team of city staff will review responses to the RFP. The following criteria will be used to evaluate the responses:

- Adequate staffing and the expertise to complete the project successfully.
- Financial and bonding for 100% of the Bid price of this project.
- Proven ability to work with municipal governments and to complete projects on time and within budget.
